#### PEACE EDUCATION

Peace education is a great complement to conflict resolution education in that it addresses local and global issues and offers a social justice perspective. It teaches concepts about peace and also skills for creating peace. It can include focuses on disarmament, human rights, multiculturalism, gender issues, and the environment, as well as on the use of non-violent conflict resolution. Similar to conflict resolution education, peace education is most effective when it is not just a module offered to students, but forms the basis for the culture of the institution, both incorporated into the curriculum and the processes for

stakeholder interaction. There is no one vision of peace education, and its manifestation in any given situation should be co-developed by stakeholders.
